

Say no to CETA! EPSU campaign materials



(15 June 2016) **EPSU will organise a series of upcoming actions against the Comprehensive Economic and Trade Agreement (CETA)** – the controversial free trade deal that has been negotiated between the European Union and Canada. **We have put together a package of campaign materials to coordinate our actions, to be shared with members, colleagues and wider networks.**

The actions will take place on **23 June (Public Service Day 2016)** and in a **week of coordinated online action, 27 June - 1 July**, before the European Commission is expected to agree its final CETA proposal on 5 July.

Public anger and resistance against CETA and other dangerous trade deals just keeps getting stronger. **But in order to truly turn the tide on CETA we must persuade national governments and parliaments to reject it, too.** Demonstrating the strength of trade union feeling against the agreement, through coordinated action, will be key to achieving this. Together we can fight to stop this dangerous deal – **Say no to CETA!**
